Artificial Intelligence and Data Science programme for II, IV, VI, and VIII semesters.

Agenda No. 1: To Confirm the Constitution of the Board of Studies.

The Chairperson informed the members about the constitution of the Board of Studies for the Department, formed in accordance with the UGC regulations and Anna University norms. The composition of the Board included the Chairperson, Anna University Nominee, Subject Experts, Industry Representative, Alumni Member, and Internal Faculty Members.

Resolution: The Board of Studies resolved to confirm and approve the constitution of the Board of Studies as per UGC and Anna University regulations.

Agenda No. 2: Review of Programme Educational Objectives (PEOs) and Programme Specific Outcomes (PSOs)

Dr. T. Senthil Kumar suggested that the Programme Educational Objectives (PEOs) be reviewed to ensure alignment with the Programme Outcomes (POs) as per Anna University guidelines, with emphasis on industry relevance, higher education opportunities, professional ethics, and the use of clear, measurable, and outcome-based statements.

After detailed deliberation, the Board observed that the existing PEOs are already well-aligned with the Programme Outcomes, adequately address industry needs, higher education, research orientation, and ethical responsibilities, and are framed using measurable and outcome-based terminology.

Dr. R. Venkatesan remarked that the Programme Specific Outcomes (PSOs) are clearly stated and hence no modification is required.

Resolution: The Board of Studies resolved that no changes are required in the existing Programme Educational Objectives (PEOs) and Programme Specific Outcomes (PSOs), as they are found to be appropriate and in compliance with Anna University guidelines. The same shall be forwarded to the Academic Council for information and approval.

Agenda No.3: Discussion of Curriculum and syllabus of Regulations 2021 for the 4th, 6th & 8th semesters of students for the academic year 2025-26.

The curriculum and syllabi for the second, third and final years will comply with the 2021 Regulations of Anna University - Chennai, and the End Semester Examinations will be administered by the College.

Resolution: BoS resolved to recommend the 4th, 6th and 8th semesters of Regulation 2021 Curriculum and Courses to the Academic Council for further approval.

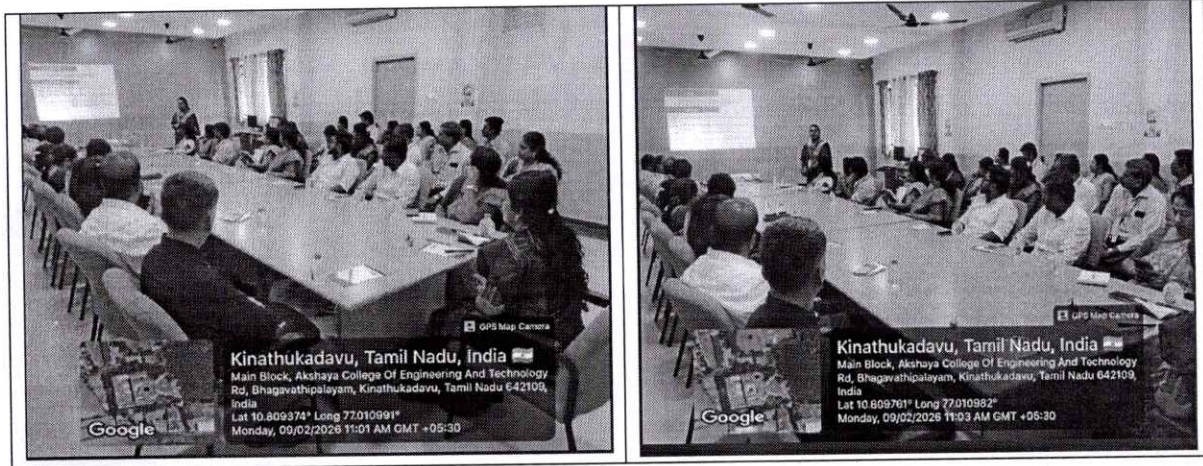
Agenda No.4: Discussion of Curriculum and syllabus of Regulations 2025 for the 2nd semester of students for the academic year 2025-26.
