






Agenda No.4: Discussion of Curriculum and syllabus of Regulations 2025 for the 2nd semester of students for the academic year 2025-26.








The curriculum and syllabi for the first year will comply with the 2025 Regulations of Anna University -Chennai, and the End Semester Examinations will be administered by the College.
