Agenda No. 1: To Confirm the Constitution of the Board of Studies.

The Chairperson informed the members about the constitution of the Board of Studies for the Department, formed in accordance with the UGC regulations and Anna University norms. The composition of the Board included the Chairperson, Anna University Nominee, Subject Experts, Industry Representative, Alumni Member, and Internal Faculty Members.

Dr.K.Yosada, Anna University Nominee suggested to ensure clear mapping of PEOs and PSOs with Programme Outcomes (POs) as well department vision and missions in line with Anna University guidelines, to incorporate industry relevance, higher education pathways, and professional ethics, and to frame the statements using measurable and outcome-based terminology.

After detailed deliberation, the Board observed that the existing department vision, mission, PEOs are already well-aligned with the Programme Outcomes, department vision and mission adequately address industry needs, higher education, research orientation, and ethical responsibilities, and are framed using measurable and outcome-based terminology.

Resolution: The Board of Studies resolved that no changes are required in the existing vision, mission, Programme Educational Objectives (PEOs) and Programme Specific Outcomes (PSOs), as they are found to be appropriate and in compliance with Anna University guidelines. The same shall be forwarded to the Academic Council for information and approval.

Agenda No.3: Discussion of Curriculum and syllabus of Regulations 2021 for the 4th and 6th semesters of students for the academic year 2025-26.

The curriculum and syllabi for the second and third years will comply with the 2021 Regulations of Anna University -Chennai, and the End Semester Examinations will be administered by the College.

Resolution: BoS resolved to recommend the 4th, 6th and 8th semesters of Regulation 2021 Curriculum and Courses to the Academic Council for further approval.

Agenda No.4: Discussion of Curriculum and syllabus of Regulations 2025 for the 2nd semester of students for the academic year 2025-26.

The curriculum and syllabi for the first year will comply with the 2025 Regulations of Anna University - Chennai, and the End Semester Examinations will be administered by the College.

Resolution: BoS resolved to recommend the 2nd semester of Regulation 2025 Curriculum and Courses to the Academic Council for further approval.
